Take the Next Step – ELS(D)

Are you ready to take the next step in your professional development? If so, you should consider applying for diplomate status, which is indicated by the post-nominal "ELS(D)." While your ELS credential demonstrates your expertise as a biomedical editor, the ELS(D) shows that you are among the upper echelon of our profession.

Editors eligible to apply for ELS(D) status must have at least 6 years of editing experience, including 2 or more years with ELS status. The initial application requires the completion of an online form and documentation of editing experience (e.g., letters of reference). Once the application is accepted, the candidate must submit a portfolio of scientific text that shows the editor's contributions. Details about the Diplomate Program and portfolio are available at <u>https://www.bels.org/diplomate-program</u>.

If you've been considering applying for diplomate status, now is the time to act. Effective January 1, 2024, the total cost will increase from the current rate of \$400 (\$100 application fee plus \$300 portfolio fee) to \$450 (\$100 application fee plus \$350 portfolio fee). Portfolios submitted by December 31, 2023, will be assessed at the current rate.




Monthly Poll Results

The Board of Editors in the Life Sciences (BELS) was founded in 1991 to evaluate the proficiency of manuscript editors in the life sciences and to award credentials similar to those obtainable in other professions.

Potential employers and clients of manuscript editors usually have no objective way to assess the proficiency of editors. For their part, editors are frustrated by the difficulty of demonstrating their ability. That is why both employers and editors so often resort to personal references or ad hoc tests, not always with satisfactory results. The need for an objective test of editorial skill has long been recognized.

To meet that need, BELS developed a process for testing and evaluating proficiency in editing in the life sciences. The Board administers two examinationsone for certification and one for diplomate status. The examinations, written by senior life-science editors assisted by testing experts, focus on the principles and practices of scientific editing in English.
